1. Purpose

The purpose of this MOU is to establish collaboration between **Seth Anandram Jaipuria College** and **APTECH Learning** to provide students with various educational opportunities, including free seminars, free basic training in technology and applications, career counselling along with job opportunities and advanced training & certification programs (payable). This collaboration is designed to enhance students' knowledge, skills, and employability.

2. Scope of Collaboration

2.1 Non-Chargeable Seminars

- **APTECH Learning** will conduct **seminars** on relevant technologies or applications. These seminars will be **free of charge** for students and will cover the basics of specific technologies.
- The seminars will be conducted either at **Seth Anandram Jaipuria College** or at an **APTECH Learning Centre**, using the facilities of the college or the APTECH Centre.

2.2 Free Training (12 Hours)

- **APTECH Learning** will provide **free training** for **12 hours**, focusing on the **basic concepts of specific technologies or applications**.
- This training will be provided in the following manner:
 - At **Seth Anandram Jaipuria College** using the college's infrastructure, or
 - At **APTECH Learning Centre**, Laketown.
- The training will cover foundational knowledge to introduce students to the chosen technologies or applications.

2.3 Career Counselling

- **APTECH Learning** will offer **career counselling** sessions for students, focusing on:
 - Guidance regarding career opportunities in the IT industry.
 - Resume building, interview preparation, and career path planning.

2.4 Paid Full-Course/Advanced Training

- **APTECH Learning** will provide **full-course advanced training** programs. These programs will be **payable** and cover advanced topics in various technologies (e.g., software development, networking, cybersecurity, data science, etc.).
- These advanced training programs will be available in two formats:
 - Conducted at **APTECH Learning Centers**.
 - Conducted at **Seth Anandram Jaipuria College**, utilizing the college's infrastructure for the sessions.
- Students who successfully complete these full-course training programs will receive **certificates** issued by **APTECH Learning & job assistance**.

3. Roles and Responsibilities

Seth Anandram Jaipuria College Responsibilities:

- Provide the necessary infrastructure, including classrooms, computers, and internet access for the seminars, free training, and paid training programs.
- Assist with student enrolment and the promotion of the training programs and seminars.
- Coordinate with **APTECH Learning** to ensure smooth execution of the seminars, free training, career counselling, and full-course training.

APTECH Learning Responsibilities:

- Deliver the seminars, free training, career counselling, and advanced training programs as per the outlined schedule.
- Provide qualified instructors, course materials, and relevant resources.
- Ensure the issuance of certificates for students who complete the full-course paid training.
- Share job opportunities with the students and assist with career counselling.

4. Duration of the MOU

This MOU will be valid for 5 Years commencing from 08/01/2025 and concluding on 07/01/2030, unless extended or terminated by mutual written consent.

5. Financial Terms

- **Free Services:** The seminars and 12-hour basic training will be provided at no charge to the students.
- **Paid Services:** The advanced training programs will be chargeable, with fees determined based on the course content and duration.

6. Confidentiality

Both parties agree to maintain the confidentiality of all proprietary, sensitive, or confidential information shared during the term of this MOU, including student data, training materials, and business-sensitive information.

7. Termination

This MOU may be terminated by either party by providing **30 days' written notice**. In the event of termination, both parties agree to fulfil any outstanding obligations or commitments.

8. Dispute Resolution

In the event of a dispute arising from this MOU, both parties will attempt to resolve the issue through mutual discussions. If the dispute cannot be resolved amicably, both parties agree to submit to arbitration in accordance with the applicable laws.
