**I. Legal Frameworks of Both the Organizations**

**SETH ANANDRAM JAIPURIA COLLEGE**, UGC approved NAAC Accredited and affiliated under the University of Calcutta and Government of West Bengal aided college, 10, Raja Nabakrishna Street, Kolkata-700005, W.B, India, hereinafter referred to as the **FIRST PARTY** (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) OF THE ONE PART

And

**PIDILITE INDUSTRIES LTD, KOLKATA** (hereinafter called "**Pidilite Industries Ltd**" or "Second Party" which expression shall where the context so admits include its successors and permitted assignees). Whereas **Pidilite Industries Ltd**. Aim to Support this Process of Learning by way of Arts & Craft, Creative Art providing by our expertise and resources to train the students.

**First Party:**

The College make arrangements for enrolment of students in a "Certificate Course in Fashion Designing" and "Certificate Course in Interior Designing" in which the students of the college is offered free of cost up to 30 candidates per batch every time.

2. The College takes the responsibility of providing a time slot and venue for conducting of the classes.

3. The College design curriculum for 30 hours and conduct examination.

4. The College also designs certificate including the name as "In association with **Pidilite**" and provides certificate to the candidates after completion of course.

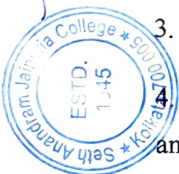
**Second Party:**

#### VALIDITY:

The MoU shall be valid, initially for a period of **Three (3) years**, extendable for another two years by mutual consent.

#### SETTLEMENT OF DISPUTES:

The parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof. If any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning operation, effect interpretation of the Agreement or breach thereof which Parties are unable to settle mutually within 30 days from the commencement of settlement proceedings and if not settled then the same shall be referred to the court of West Bengal Jurisdiction.

#### TERMINATION:

This MoU may be terminated by giving a notice of three months or the conclusion of on-going programs, whichever is later, from either side.

This memorandum which is in 3 pages is signed on 24th day of JUNE 2024 and exchanged in at **SETH ANANDRAM JAIPURIA COLLEGE** on 24th day of JUNE 2024.
