1. Background:

Both institutions acknowledge the importance of practical exposure and skill development for undergraduate students pursuing courses in Commerce, Arts, and Science. Recognizing the mutual benefits of collaboration, Seth Anandram Jaipuria College and The National Council of Education, Bengal, intend to collaborate on the development and implementation of add-on courses and internship programmes.

2. Objectives:

The objectives of this collaboration are:

- To provide opportunities for students to engage in meaningful community service initiatives.
- To equip students with essential skills and knowledge in business studies, counselling, research, publication, and archival studies.
- To foster mutual learning and exchange of ideas between the institutions.

3. Areas of Collaboration:

The parties agree to collaborate in the following areas:

- Social Work & Community Services
- Business Studies
- Counselling & Promotion of Wellbeing
- Research in Comparative Philosophy of Religion and Cultural Studies
- Publication and Archive Studies

4. Responsibilities:

Each institution shall:

- Design and develop curriculum for the agreed-upon courses and programmes.
- Facilitate internship opportunities for students.
- Provide necessary resources and support for the successful implementation of the collaboration.

- There shall be no financial responsibility on the part of NCEB.
- NCEB shall issue certificates at the end of each Internship/Add on programme.

5. Duration:

This MoU shall commence on the 30th day of April, 2024 and remain in effect for a period of five years. It may be extended by mutual agreement between the parties.
